Describe your major areas of work experience/expertise: I have experience in design, engineering, construction management, project management, contract administration, contract claims consulting, CPM scheduling, estimating, and testing. I have worked on Airports, Courthouses, Commercial Bldgs, Defense, Custom Residential, Dams, Fiber Optic Cable, High Rises, Highways, Hospitals, Hotels, Industrial, Municipal, Multi-Family, Power Plants, Prisons, Recreational, Refineries, Schools, and Sewage Treatment Projects.
2. Describe your experience with construction claims: I have twenty five years experience as a Construction Claims Consultant. My clients have included municipal, state and federal agencies, general contractors, subcontractors, architects, engineers, OEM Manufacturers, attorneys, insurance companies, sureties, financial sector, developers, owners and HOA's.
3. Describe your knowledge of construction contract law:

In addition to my claims consulting experience, I have taken business law classes as part of my MBA program, a contract preparation class as part of the Post Graduate ADR Certificate program and several construction industry contract law seminars. I have served as a Contract Administrator and I am a student of construction case law precedents.

4. Describe your experience with construction contract administration:

I reviewed and commented on proposed construction contracts, negotiated contract language modifications, prepared and negotiated contract change orders, prepared requests for equitable adjustment and formal claims reports.
